

CHAPTER 97-94

Senate Bill No. 418

An act relating to the Florida Statutes; repealing ss. 159.811(2), 206.065, 206.425, 206.426, 212.60, 212.61, 212.62, 212.6201, 212.635, 212.637, 212.64, 212.65, 212.655, 212.66, 212.67, 232.165, 258.024, 366.84, 403.709(3)(f), 409.7015, 461.006(1)(d), 468.385(9)-(13), 468.387(2), (3), 468.389(2)(d), 491.0055, 617.0122(24), 617.01225, 627.837, 768.73(2)-(7), 790.06(13)(b), 946.40(5), and 946.508, Florida Statutes, and ss. 212.05(1)(g), 216.292(11), 255.25(4)(c), 259.032(11)(d)2., 288.1065, 373.59(15), 403.7197, 550.01215(9)(b), 627.351(5)(a)1.d.(II), 790.065(1)(b)2., 950.002(10), (11), and 958.04(4), Florida Statutes (1996 Supplement), pursuant to s. 11.242, Florida Statutes; all of which provisions have become inoperative by noncurrent repeal or expiration and, pursuant to s. 11.242(5)(b) and (i), may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsection (2) of section 159.811, Florida Statutes, is repealed.

Reviser's note.—The cited subsection, which relates to deposit and use of fees collected under s. 159.811, Florida Statutes, was repealed by s. 15, ch. 94-265, Laws of Florida, effective July 1, 1995. Since the section was not repealed by a "current session" of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 2. Section 206.065, Florida Statutes, is repealed.

Reviser's note.—The cited section, which relates to motor and fuel tax purchases by licensed wholesalers and licensed importers, was repealed by s. 13, ch. 95-417, Laws of Florida, effective July 1, 1996. Since the section was not repealed by a "current session" of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 3. Sections 206.425 and 206.426, Florida Statutes, are repealed.

Reviser's note.—The cited sections, which relate to tax-exempt purchasers and resale and exemption certificates, were repealed by s. 44, ch. 95-417, Laws of Florida, effective July 1, 1996. Since the sections were not repealed by a "current session" of the Legislature, they may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 4. Sections 212.60, 212.61, 212.62, 212.6201, 212.635, 212.637, 212.64, 212.65, 212.655, 212.66, and 212.67, Florida Statutes, are repealed.

Reviser's note.—The cited sections, which relate to sales tax on motor fuels and special fuels, were repealed by s. 115, ch. 95-417, Laws of Florida, effective July 1, 1996. Since the sections were not repealed by

a “current session” of the Legislature, they may be omitted from the Florida Statutes 1997 only through a reviser’s bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 5. Section 232.165, Florida Statutes, is repealed.

Reviser’s note.—The cited section, which relates to nonissuance or suspension of a driver’s license for student nonenrollment or nonattendance, was repealed by s. 4, ch. 93-144, Laws of Florida, effective July 1, 1996. Since the section was not repealed by a “current session” of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser’s bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 6. Section 258.024, Florida Statutes, is repealed.

Reviser’s note.—The cited section, which relates to police powers of park law enforcement officers, was repealed by s. 515, ch. 94-356, Laws of Florida, effective July 1, 1995. Since the section was not repealed by a “current session” of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser’s bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 7. Section 366.84, Florida Statutes, is repealed.

Reviser’s note.—The cited section, which relates to creation of the Florida Energy Trust Fund, was repealed by s. 14, ch. 95-372, Laws of Florida, effective July 1, 1996. Since the section was not repealed by a “current session” of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser’s bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 8. Paragraph (f) of subsection (3) of section 403.709, Florida Statutes, is repealed.

Reviser’s note.—The cited paragraph, which relates to grants to counties for landfill closure costs as authorized in the 1995-1996 General Appropriations Act, expired pursuant to its own terms, effective July 1, 1996.

Section 9. Section 409.7015, Florida Statutes, as amended by section 4 of chapter 94-118, Laws of Florida, is repealed.

Reviser’s note.—The cited section, which relates to unemployment compensation data availability, expired pursuant to its own terms, effective October 1, 1995.

Section 10. Paragraph (d) of subsection (1) of section 461.006, Florida Statutes, is repealed.

Reviser’s note.—The cited paragraph, which relates to clinical experience requirements for podiatrists, expired pursuant to s. 2, ch. 90-29, Laws of Florida, effective October 1, 1995.

Section 11. Subsections (9)-(13) of section 468.385, Florida Statutes, as amended by section 138 of chapter 94-218, Laws of Florida; subsections (2) and (3) of section 468.387, Florida Statutes, as amended by section 18 of chapter 94-119, Laws of Florida; and paragraph (d) of subsection (2) of section 468.389, Florida Statutes, are repealed.

Reviser's note.—The cited provisions, which relate to bonding of auctioneers and auction businesses, were repealed by s. 16, ch. 91-207, Laws of Florida, effective October 1, 1995. Since the provisions were not repealed by a “current session” of the Legislature, they may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 12. Section 491.0055, Florida Statutes, is repealed.

Reviser's note.—The cited section, which relates to licensure of mental health counselors under special conditions between December 1, 1995, and February 28, 1996, expired pursuant to its own terms, effective September 30, 1996.

Section 13. Subsection (24) of section 617.0122, Florida Statutes, as amended by section 469 of chapter 94-356, Laws of Florida, is repealed.

Reviser's note.—The cited subsection, which relates to a supplemental corporate fee, was repealed by s. 27, ch. 94-314, Laws of Florida, effective January 1, 1996. Since the subsection was not repealed by a “current session” of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 14. Section 617.01225, Florida Statutes, is repealed.

Reviser's note.—The cited section, which relates to a supplemental corporate fee, was repealed by s. 28, ch. 94-314, Laws of Florida, effective January 1, 1996. Since the section was not repealed by a “current session” of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 15. Section 627.837, Florida Statutes, is repealed.

Reviser's note.—The cited section, which relates to prohibition of rebates and inducements by premium finance companies, expired pursuant to its own terms, effective July 1, 1996.

Section 16. Subsections (2)-(7) of section 768.73, Florida Statutes, are repealed.

Reviser's note.—The cited subsections, which relate to punitive damages, were repealed by s. 3, ch. 92-85, Laws of Florida, effective July 1, 1995. Since the subsections were not repealed by a “current session” of the Legislature, they may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 17. Paragraph (b) of subsection (13) of section 790.06, Florida Statutes, is repealed.

Reviser's note.—The cited paragraph, which relates to transfer of funds from the Licensing Trust Fund of the Department of State to the Operating Trust Fund of the Department of Highway Safety and Motor Vehicles, expired pursuant to its own terms, effective July 1, 1996.

Section 18. Subsection (5) of section 946.40, Florida Statutes, is repealed.

Reviser's note.—The cited subsection, which relates to use of a portion of the monthly cost of supervision fee for administration of the Inmate Work Program, was repealed by s. 3, ch. 94-265, Laws of Florida, effective July 1, 1995. Since the subsection was not repealed by a "current session" of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 19. Section 946.508, Florida Statutes, is repealed.

Reviser's note.—The cited section, which relates to the Correctional Work Program Revolving Trust Fund, was repealed by s. 7, ch. 94-265, Laws of Florida, effective July 1, 1995. Since the section was not repealed by a "current session" of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242 (5)(b) and (i).

Section 20. Paragraph (g) of subsection (1) of section 212.05, Florida Statutes (1996 Supplement), is repealed.

Reviser's note.—The cited paragraph, which relates to the sales tax rate for motor fuel or special fuel under pt. II of ch. 212, was repealed by s. 112, ch. 95-417, Laws of Florida, effective July 1, 1996. Since the paragraph was not repealed by a "current session" of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 21. Subsection (11) of section 216.292, Florida Statutes (1996 Supplement), is repealed.

Reviser's note.—The cited subsection, which relates to transfer of positions and appropriations to implement the reorganization of the Department of Education for the 1995-1996 fiscal year only, expired pursuant to its own terms, effective July 1, 1996.

Section 22. Paragraph (c) of subsection (4) of section 255.25, Florida Statutes (1996 Supplement), is repealed.

Reviser's note.—The cited paragraph, which relates to the Public Facilities Conversion Revolving Trust Fund, was repealed by s. 12, ch. 94-265, effective July 1, 1995. Since the paragraph was not repealed by a "current session" of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 23. Subparagraph 2. of paragraph (d) of subsection (11) of section 259.032, Florida Statutes (1996 Supplement), is repealed.

Reviser's note.—The cited subparagraph, which relates to appropriation of funds for control and eradication of nuisance aquatic plants, expired pursuant to its own terms, effective July 1, 1996.

Section 24. Section 288.1065, Florida Statutes (1996 Supplement), as amended by section 136 of chapter 96-406, Laws of Florida, is repealed.

Reviser's note.—The cited section, which relates to the confidentiality of certain information required pursuant to former s. 288.104, Florida Statutes, expired pursuant to s. 3, ch. 93-420, Laws of Florida, effective April 15, 1994.

Section 25. Subsection (15) of section 373.59, Florida Statutes (1996 Supplement), as amended by section 17 of chapter 96-389, Laws of Florida, is repealed.

Reviser's note.—The cited subsection, which relates to request for and release of moneys allocated to water management districts for certain purposes, expired pursuant to its own terms, effective July 1, 1996.

Section 26. Section 403.7197, Florida Statutes (1996 Supplement), as amended by section 17 of chapter 95-430, Laws of Florida; section 241 of chapter 96-406, Laws of Florida; and section 156 of chapter 96-410, Laws of Florida, is repealed.

Reviser's note.—The cited section, which relates to the advance disposal fee, expired pursuant to section 72, chapter 88-130, Laws of Florida, effective October 1, 1995.

Section 27. Paragraph (b) of subsection (9) of section 550.01215, Florida Statutes (1996 Supplement), is repealed.

Reviser's note.—The cited paragraph, which relates to operation of intertrack wagering by certain pari-mutuel permitholders, expired pursuant to its own terms, effective October 1, 1996.

Section 28. Sub-sub-subparagraph (II) of sub-subparagraph d. of subparagraph 1. of paragraph (a) of subsection (5) of section 627.351, Florida Statutes (1996 Supplement), as amended by section 9 of chapter 95-276, Laws of Florida, is repealed.

Reviser's note.—The cited provision, which relates to property and casualty insurance classifications eligible for coverage under certain circumstances, expired pursuant to its own terms, effective July 1, 1996.

Section 29. Subparagraph 2. of paragraph (b) of subsection (1) of section 790.065, Florida Statutes (1996 Supplement), is repealed.

Reviser's note.—The cited provision, which relates to transfer of excess funds to the General Revenue Fund for the 1995-1996 fiscal year only, expired pursuant to its own terms, effective July 1, 1996.

Section 30. Subsections (10) and (11) of section 950.002, Florida Statutes (1996 Supplement), are repealed.

Reviser's note.—The cited subsections, which relate to the Community Corrections Construction Trust Fund and the Community Corrections Operating Trust Fund, respectively, were repealed by s. 5, ch. 94-265, Laws of Florida, effective July 1, 1995. Since the subsections were not repealed by a "current session" of the Legislature, they may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).

Section 31. Subsection (4) of section 958.04, Florida Statutes (1996 Supplement), is repealed.

Reviser's note.—The cited subsection, which relates to a basic training program for youthful offenders, was repealed by s. 101, ch. 94-209, Laws of Florida, effective July 1, 1995. Since the subsection was not repealed by a "current session" of the Legislature, it may be omitted from the Florida Statutes 1997 only through a reviser's bill duly enacted by the Legislature. See s. 11.242(5)(b) and (i).
