CHAPTER 2004-286

Senate Bill No. 1768

An act relating to possession of ammunition by felons and delinquents; amending s. 790.001, F.S.; providing a definition of the term "ammunition"; amending s. 790.23, F.S.; including ammunition among the specified items for which possession by a felon or delinquent constitutes a felony of the second degree; providing penalties; amending s. 790.235, F.S.; including ammunition among the specified items for which possession by a violent career criminal subjects such criminal to a mandatory minimum prison sentence; providing penalties; amending s. 921.0022, F.S., relating to the offense severity ranking chart, to conform; reenacting s. 790.01(5), F.S., relating to carrying concealed weapons, to incorporate the amendments to ss. 790.23 and 790.235, F.S., in references thereto; providing applicability; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsection (19) is added to section 790.001, Florida Statutes, to read:

790.001 Definitions.—As used in this chapter, except where the context otherwise requires:

(19) "Ammunition" means an object consisting of all of the following:

(a) A fixed metallic or nonmetallic hull or casing containing a primer.

(b) One or more projectiles, one or more bullets, or shot.

(c) Gunpowder.

<u>All of the specified components must be present for an object to be ammunition.</u>

Section 2. Section 790.23, Florida Statutes, is amended to read:

790.23 Felons and delinquents; possession of firearms, <u>ammunition</u>, or electric weapons or devices unlawful.—

(1) It is unlawful for any person to own or to have in his or her care, custody, possession, or control any firearm, <u>ammunition</u>, or electric weapon or device, or to carry a concealed weapon, including a tear gas gun or chemical weapon or device, if that person has been:

(a) Convicted of a felony in the courts of this state;

(b) Found, in the courts of this state, to have committed a delinquent act that would be a felony if committed by an adult and such person is under 24 years of age_{27} .

(c) Convicted of or found to have committed a crime against the United States which is designated as a felony;

(d) Found to have committed a delinquent act in another state, territory, or country that would be a felony if committed by an adult and which was punishable by imprisonment for a term exceeding 1 year and such person is under 24 years of age; or

(e) Found guilty of an offense that is a felony in another state, territory, or country and which was punishable by imprisonment for a term exceeding 1 year.

(2) This section shall not apply to a person convicted of a felony whose civil rights and firearm authority have been restored.

(3) Any person who violates this section commits a felony of the second degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

Section 3. Section 790.235, Florida Statutes, is amended to read:

790.235 Possession of firearm <u>or ammunition</u> by violent career criminal unlawful; penalty.—

(1) Any person who meets the violent career criminal criteria under s. 775.084(1)(d), regardless of whether such person is or has previously been sentenced as a violent career criminal, who owns or has in his or her care, custody, possession, or control any firearm, <u>ammunition</u>, or electric weapon or device, or carries a concealed weapon, including a tear gas gun or chemical weapon or device, commits a felony of the first degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084. A person convicted of a violation of this section shall be sentenced to a mandatory minimum of 15 years' imprisonment; however, if the person would be sentenced to a longer term of imprisonment under s. 775.084(4)(d), the person must be sentenced under that provision. A person convicted of a violation of this section is not eligible for any form of discretionary early release, other than pardon, executive clemency, or conditional medical release under s. 947.149.

(2) For purposes of this section, the previous felony convictions necessary to meet the violent career criminal criteria under s. 775.084(1)(d) may be convictions for felonies committed as an adult or adjudications of delinquency for felonies committed as a juvenile. In order to be counted as a prior felony for purposes of this section, the felony must have resulted in a conviction sentenced separately, or an adjudication of delinquency entered separately, prior to the current offense, and sentenced or adjudicated separately from any other felony that is to be counted as a prior felony.

(3) This section shall not apply to a person whose civil rights and firearm authority have been restored.

Section 4. Paragraph (e) of subsection (3) of section 921.0022, Florida Statutes, is amended to read:

921.0022 Criminal Punishment Code; offense severity ranking chart.—

Section 5. For the purpose of incorporating the amendments to sections 790.23 and 790.235, Florida Statutes, in references thereto, subsection (5) of section 790.01, Florida Statutes, is reenacted to read:

790.01 Carrying concealed weapons.—

(5) This section does not preclude any prosecution for the use of an electric weapon or device or remote stun gun or self-defense chemical spray during the commission of any criminal offense under s. 790.07, s. 790.10, s. 790.23, or s. 790.235, or for any other criminal offense.

Section 6. This act shall take effect October 1, 2004, and shall apply to offenses committed on or after that date.
