## Committee Substitute for Committee Substitute for Senate Bill Nos. 1160 and 2566

An act relating to building and facility designations; providing for the designation of buildings and facilities at the University of Florida, the University of South Florida, the University of Central Florida, and Florida International University; directing the universities to erect suitable markers; designating the Department of Education office at 921 N. Davis Street in Jacksonville as the "Mary L. Singleton Education Office"; directing the Department of Education to erect suitable markers; designating the administration building at the Florida State Hospital in Chattahoochee as the "William DeWitt Rogers Administration Building"; directing the Department of Children and Family Services to erect suitable markers; designating the Florida Barbara B. Lumpkin Center for Nursing"; directing the Department of Health to erect suitable markers; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. <u>Bispham Turfgrass Support Building designated; University</u> of Florida to erect suitable markers.—

(1) Bispham Turfgrass Hall at the University of Florida is designated as the "Bispham Turfgrass Support Building."

(2) The University of Florida is directed to erect suitable markers designating the Bispham Turfgrass Support Building as described in subsection (1).

Section 2. <u>Mark Bostick Golf Course designated; University of Florida to</u> <u>erect suitable markers.</u>

(1) The golf course at the University of Florida is designated as the "Mark Bostick Golf Course."

(2) The University of Florida is directed to erect suitable markers designating the Mark Bostick Golf Course as described in subsection (1).

Section 3. <u>L. Gale Lemerand Football Support Facility designated; University of Florida to erect suitable markers.</u>

(1) The support building on the football practice fields at the University of Florida is designated as the "L. Gale Lemerand Football Support Facility."

(2) The University of Florida is directed to erect suitable markers designating the L. Gale Lemerand Football Support Facility as described in subsection (1).

Section 4. <u>Katie Seashole Pressly Stadium designated</u>; <u>University of Florida to erect suitable markers.</u>

(1) The softball stadium at the University of Florida is designated as the <u>"Katie Seashole Pressly Stadium."</u>

(2) The University of Florida is directed to erect suitable markers designating the Katie Seashole Pressly Stadium as described in subsection (1).

Section 5. <u>Frank and Carol Morsani Center for Advanced Health Care</u> <u>designated; University of South Florida to erect suitable markers.</u>

(1) The complex being constructed at Magnolia and Holly Drive on the USF Tampa Campus, is designated as the "Frank and Carol Morsani Center for Advanced Health Care."

(2) The University of South Florida is directed to erect suitable markers designating the Frank and Carol Morsani Center for Advanced Health Care as described in subsection (1).

Section 6. <u>Glenn Burdick College of Engineering Building designated;</u> <u>University of South Florida to erect suitable markers.</u>

(1) The College of Engineering Building II at 3820 USF-Alumni Drive on the USF Tampa Campus is designated as the "Glenn Burdick College of Engineering Building."

(2) The University of South Florida is directed to erect suitable markers designating the Glenn Burdick College of Engineering Building as described in subsection (1).

Section 7. <u>Alfred and Rose Schiff Dean's Conference Room designated;</u> <u>University of South Florida to erect suitable markers.</u>

(1) The Dean's Conference Room in the College of Engineering Building II at 3820 USF-Alumni Drive on the USF Tampa Campus is designated as the "Alfred and Rose Schiff Dean's Conference Room."

(2) The University of South Florida is directed to erect suitable markers designating the Alfred and Rose Schiff Dean's Conference Room as described in subsection (1).

Section 8. <u>Nicholson School of Communication Building designated; University of Central Florida to erect suitable markers.</u>

(1) The Communication Building at the University of Central Florida is designated as the "Nicholson School of Communication."

(2) The University of Central Florida is directed to erect suitable markers designating the Nicholson School of Communication as described in subsection (1).

Section 9. <u>Anthony and Sonja Nicholson Field House designated; Univer</u><u>sity of Central Florida to erect suitable markers.</u>

(1) The athletics indoor practice facility at the University of Central Florida is designated as the "Anthony and Sonja Nicholson Field House."

(2) The University of Central Florida is directed to erect suitable markers designating the Anthony and Sonja Nicholson Field House as described in subsection (1).

Section 10. James and Annie Ying Academic Center designated; University of Central Florida to erect suitable markers.—

(1) The building that houses the University of Central Florida Downtown Center is designated as the "James and Annie Ying Academic Center."

(2) The University of Central Florida is directed to erect suitable markers designating the James and Annie Ying Academic Center as described in subsection (1).

Section 11. <u>Burnett Biomedical Sciences Building designated; University</u> of Central Florida health sciences campus at Lake Nona to erect suitable markers.—

(1) The Biomedical Sciences Building at the University of Central Florida health sciences campus at Lake Nona is designated as the "Burnett Biomedical Sciences Building."

(2) The University of Central Florida is directed to erect suitable markers designating the Burnett Biomedical Sciences Building as described in subsection (1).

Section 12. <u>Mary L. Singleton Education Office designated; Department</u> of Education to erect suitable markers.—

(1) The Department of Education office at 921 N. Davis Street in Jacksonville is designated as the "Mary L. Singleton Education Office."

(2) The Department of Education is directed to erect suitable markers designating the Mary L. Singleton Education Office as described in subsection (1).

Section 13. <u>William DeWitt Rogers Administration Building designated;</u> Department of Children and Family Services to erect suitable markers.—

(1) The administration building at the Florida State Hospital in Chattahoochee is designated as the "William DeWitt Rogers Administration Building."

(2) The Department of Children and Family Services is directed to erect suitable markers designating the William DeWitt Rogers Administration Building as described in subsection (1).

Section 14. <u>Florida Barbara B. Lumpkin Center for Nursing designated;</u> <u>Department of Health to erect suitable markers.</u>

(1) The Florida Center for Nursing, created by s. 464.0195, Florida Statutes, and located in Orlando, is designated as the "Florida Barbara B. Lumpkin Center for Nursing."

(2) The Department of Health is directed to erect suitable markers designating the Florida Barbara B. Lumpkin Center for Nursing as described in subsection (1).

Section 15. <u>Ronald W. Reagan Presidential House designated; Florida</u> <u>International University to erect suitable markers.</u>

(1) University House at Florida International University is designated as the "Ronald W. Reagan Presidential House."

(2) Florida International University is authorized to erect suitable markers designating the Ronald W. Reagan Presidential House as described in subsection (1).

Section 16. This act shall take effect July 1, 2007.
