## CHAPTER 2017-203

## Committee Substitute for House Bill No. 921

An act relating to Fellsmere Drainage District, Indian River County; codifying the district's charter pursuant to s. 189.019, Florida Statutes; providing legislative intent; amending, codifying, reenacting, and repealing special acts relating to the district; repealing chs. 8877 (1921), 11555 (1925), 12023 (1927), 14719 (1931), 16998 (1935), 28418 (1953), 61-1414, and 69-1161, Laws of Florida, relating to the Fellsmere Drainage District; changing the name of the district to the Fellsmere Water Control District; removing the 99-year term limitation of the district originally provided by court decree; amending the boundaries of the district; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Pursuant to s. 189.019, Florida Statutes, this act constitutes the codification of all special acts and court decrees relating to the Fellsmere Drainage District. This act shall also serve to formally change the name of the district to the Fellsmere Water Control District pursuant to s. 298.001, Florida Statutes; remove the 99-year term limitation of the district originally provided by court decree in the case In re: Fellsmere Drainage District issued on April 8, 1919, by the Circuit Court of the Fifteenth Judicial Circuit, in and for St. Lucie County, so that the Fellsmere Water Control District shall continue in existence and authority as provided in this act; and amend the boundaries of the district to reflect lands that are no longer located within the district. It is the intent of the Legislature in enacting this act to provide a single, comprehensive special act charter for the district, including all current legislative authority granted to the district by its several legislative enactments and any additional authority granted by this act. It is the further intent of the Legislature that this act preserve all district authority in addition to any authority contained in chapter 298, Florida Statutes.

Section 2. <u>Chapters 8877 (1921), 11555 (1925), 12023 (1927), 14719</u> (1931), 16998 (1935), 28418 (1953), 61-1414, and 69-1161, Laws of Florida, are amended, codified, reenacted, and repealed as herein provided.

Section 3. The Fellsmere Water Control District, formerly known as the Fellsmere Drainage District, is re-created, and the charter for such district is re-created and reenacted to read:

Section 1. Status and boundaries of Fellsmere Water Control District. The Fellsmere Water Control District is declared to be an independent water control district and a public corporation of the state pursuant to chapters 189 and 298, Florida Statutes, and the lands lying within the area described as follows in Indian River County shall constitute the Fellsmere Water Control District:

THENCE RUN WESTERLY ALONG THE LINE BEING 200 FEET SOUTH OF, NORMAL TO, AND PARALLEL WITH THE NORTH BOUNDARY LINE OF SAID TRACT 1122, APPROXIMATELY 0.13 MILES TO THE INTERSECTION WITH A LINE BEING 680 FEET WEST OF, NORMAL TO, AND PARALLEL WITH THE EAST BOUNDARY LINE OF SAID TRACT 1122, AND TRACT 1022 OF SAID "PLAT OF FELLSMERE FARMS COMPANY'S SUBDIVISION OF UNSURVEYED TOWNSHIP 32 SOUTH, RANGE 36 EAST";

THENCE RUN NORTHERLY ALONG SAID PARALLEL LINE, APPROXIMATELY 0.12 MILES, ACROSS SAID TRACTS 1122, "DITCH AND ROAD 34", TRACT 1022 TO THE INTERSECTION WITH THE NORTH LINE OF THE SOUTH 400 FEET OF SAID TRACT 1022, SAID NORTH LINE BEING A PORTION OF THOSE CERTAIN PARCELS OF LAND OF THE ST. JOHNS RIVER WATER MANAGEMENT DISTRICT "QUIT CLAIM DEED" RECORDED IN OFFICIAL RECORDS BOOK 2042, PAGE 2262, PUBLIC RECORDS OF INDIAN RIVER COUNTY, FLORIDA, AS MENTIONED IN "SPECIAL WARRANTY DEED", OFFICIAL RECORDS BOOK 722, PAGE 1151, PUBLIC RECORDS OF INDIAN RIVER COUNTY, FLORIDA;

THENCE RUN WESTERLY ALONG SAID NORTH LINE APPROXI-MATELY 0.13 MILES TO THE WEST BOUNDARY LINE OF SAID TRACT 1022;

THENCE RUN SOUTHERLY ALONG SAID WEST BOUNDARY LINE OF TRACT 1022, ALSO BEING THE EAST BOUNDARY LINE OF TRACT 1021 OF SAID PLAT OF FELLSMERE FARMS COMPANY'S SUBDIVISION OF UNSURVEYED TOWNSHIP 32 SOUTH, RANGE 36 EAST, APPROXIMATELY 0.02 MILES TO THE INTERSECTION WITH THE NORTH LINE OF THE SOUTH 310 FEET OF SAID

TRACT 1021, AND TRACTS 1020, 1019, 1018, 1017, 1016 AND 1015 OF SAID PLAT OF FELLSMERE FARMS COMPANY'S SUBDIVI-SION OF UNSURVEYED TOWNSHIP 32 SOUTH, RANGE 36 EAST. Section 2. Minimum charter requirements.—In accordance with s. 189.031(3), Florida Statutes, the following are the minimum requirements for the charter of the Fellsmere Water Control District:

(1) The district is organized and exists for all purposes set forth in this act and chapter 298, Florida Statutes, as may be amended from time to time.

(2) The district's charter may be amended only by special act of the Legislature.

(3) In accordance with chapter 189, Florida Statutes, this act, and ss. 298.11 and 298.12, Florida Statutes, as may be amended from time to time, the governing board of the district shall be designated the "Board of Supervisors of the Fellsmere Water Control District" and shall be composed of three persons, who shall be qualified to hold such office if they are landowners within the district, residents of the state, and citizens of the United States, elected on a 1-acre, one-vote basis by the landowners in the district; however, landowners with more than 1 acre in the aggregate shall be entitled to one vote. Landowners with more than 1 acre shall be entitled to one additional vote for any fraction of an acre greater than ½ acre owned when a landowner's acreage has been aggregated for purposes of voting. The membership and organization of the governing board shall be as set forth in this charter and chapter 298, Florida Statutes, as may be amended from time to time, provided this charter controls with respect to any inconsistency.

(4) The compensation of the governing board members shall be governed by this act and chapter 298, Florida Statutes, as may be amended from time to time.

(5) The administrative duties of the governing board shall be as set forth in this act and chapters 189 and 298, Florida Statutes, as may be amended from time to time.

(6) Requirements for financial disclosure, meeting notices, reporting, public records maintenance, and per diem expenses for district officers and employees shall be as set forth in chapters 112, 189, 190, 286, and 298, Florida Statutes, and all other applicable general laws of the state, as may be amended from time to time.

(7) The procedures and requirements governing the issuance of bonds, notes, and other evidence of indebtedness by the district shall be as set forth in chapters 189 and 298, Florida Statutes, and applicable general laws, as may be amended from time to time.

(8) The procedures for conducting district elections or referenda and for qualification of electors shall be pursuant to chapters 189 and 298, Florida Statutes, as may be amended from time to time; however, a quorum for purposes of holding the annual meeting or any special meetings shall consist of those landowners present in person or represented by proxy at said meeting.

(9) The district may be financed by any method established in this act, chapter 298, Florida Statutes, and other applicable general laws of the state, as may be amended from time to time.

(10) The methods for collecting non-ad valorem assessments, fees, or service charges shall be as set forth in chapters 197 and 298, Florida Statutes, and other applicable general laws of the state, as may be amended from time to time.

(11) The district's planning requirements shall be as set forth in chapters 189 and 298, Florida Statutes, as may be amended from time to time.

(12) The district's geographic boundary shall be as set forth in this act.

Section 3. Provisions of chapter 298, Florida Statutes, made applicable. The Fellsmere Water Control District is an independent water control district and a public corporation of this state. The provisions of state law applicable to water control districts or subdistricts which are embodied in chapter 298, Florida Statutes, as may be amended from time to time, so far as not inconsistent with this act, are declared to be applicable to the Fellsmere Water Control District. The Fellsmere Water Control District shall have all of the powers and authority conferred in this act and chapter 298, Florida Statutes, as may be amended from time to time.

Section 4. Severability.—If any provision of this act or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared severable.

Section 5. Construction.—This act shall be construed as a remedial act and shall be liberally construed to promote the purpose for which it is intended.

Section 4. <u>Chapters 8877 (1921), 11555 (1925), 12023 (1927), 14719</u> (1931), 16998 (1935), 28418 (1953), 61-1414, and 69-1161, Laws of Florida, are repealed.

Section 5. This act shall take effect upon becoming a law.
