## Committee Substitute for Committee Substitute for House Bill No. 389

An act relating to transportation facility designations; providing honorary designations of certain transportation facilities in specified counties; amending ch. 65-781, Laws of Florida; redesignating a specified bridge in St. Lucie County as "E.C. Summerlin Family Bridge"; directing the Department of Transportation to erect suitable markers; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. <u>Transportation facility designations; Department of Transportation to erect suitable markers.</u>

(1) That portion of I-75 between U.S. 17/Duncan Road and Harbor View Road in Charlotte County is designated as "Deputy Sheriff Christopher Taylor Memorial Highway."

(2) That portion of U.S. 19 between Palm View Road and Terra Ceia Road in Manatee County is designated as "Army Specialist Nicholas Panipinto Memorial Highway."

(3) The mid-block crossing and pedestrian hybrid beacon on that portion of E. University Avenue/S.R. 26 between N.E. 26th Terrace and S.E. 26th Terrace in Alachua County is designated as "Dylan Roberts Memorial Crosswalk."

(4) Those portions of the Gandy Bridge on U.S. 92 located within the geographical boundaries of Hillsborough and Pinellas Counties are designated as "AWF3 Mohammed 'Mo' Haitham Memorial Way."

(5) That portion of S.R. 434 between S.R. 400 and Ronald Reagan Boulevard in Seminole County is designated as "Deputy Sheriff George Pfeil Memorial Highway."

(6) That portion of U.S. 17-92 between 1st Street and 25th Street in Seminole County is designated as "Deputy Sheriff Robert Moore Memorial Highway."

(7) That portion of C.R. 419 between Snow Hill Road and the Orange County line in Seminole County is designated as "Deputy Sheriff James Cleveland Jacobs Memorial Highway."

(8) That portion of Bay Avenue between W. 25th Street and W. 27th Street in Sunset Islands in Miami-Dade County is designated as "Abe Resnick Drive."

(9) That portion of S.W. 168th Street between U.S. 1 and S.W. 89th Avenue in Miami-Dade County is designated as "Pastor Rick Blackwood Street."

(10) That portion of S.R. 16 between C.R. 225 and Rifle Range Road in Clay County is designated as "Gus Kopelousos Memorial Highway."

(11) That portion of S.R. 997/Krome Avenue/W. 177th Avenue between S.W. 8th Street and the entrance to the Miccosukee Casino & Resort in Miami-Dade County is designated as "MICCO WAY."

(12) That portion of S.R. 59 between U.S. 90 and U.S. 27 in Leon and Jefferson Counties is designated as "Major John Leroy Haynes Memorial Highway."

(13) That portion of I-10 between the Alabama state line and I-75 is designated as "Tuskegee Airmen Memorial Highway."

(14) That portion of S.R. 570/Polk Parkway between mile marker 3.5 and mile marker 2.5 in Polk County is designated as "Randy Roberts Memorial Highway."

(15) That portion of S.R. 35/George Jenkins Boulevard between Kathleen Road and N. Sloan Avenue in Polk County is designated as "Carol Jenkins Barnett Memorial Highway."

(16) That portion of I-95 between mile markers 115 and 120 in St. Lucie County is designated as "Trooper Zachary Fink Memorial Highway."

(17) The Department of Transportation is directed to erect suitable markers designating the transportation facilities as described in this section.

Section 2. Sections 1 and 2 of chapter 65-781, Laws of Florida, are amended to read:

Section 1. <u>Upon completion of construction, the new S.R. A1A North</u> <u>Causeway Bridge over the Intracoastal Waterway</u> The north bridge in St. Lucie County across Indian River on highway A-1-A is <u>designated as "E.C.</u> <u>Summerlin Family</u> hereby dedicated and named the "D. H. 'Banty' Saunders Bridge."

Section 2. The state road Department <u>of Transportation</u> is <u>directed to</u> <u>erect suitable markers designating E.C. Summerlin Family authorized and</u> <u>empowered to affix proper plaques to said bridge bearing the name "D. H.</u> 'Banty' Saunders Bridge <u>as described in section 1.</u>"

Section 3. This act shall take effect July 1, 2024.
