

CHAPTER 2025-205

Senate Bill No. 7022

An act relating to retirement; amending s. 121.71, F.S.; revising required employer retirement contribution rates for each membership class and subclass of the Florida Retirement System; providing a declaration of important state interest; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsections (4) and (5) of section 121.71, Florida Statutes, are amended to read:

121.71 Uniform rates; process; calculations; levy.—

(4) Required employer retirement contribution rates for each membership class and subclass of the Florida Retirement System for both retirement plans are as follows:

Regular Class	<u>7.10%</u> 6.73%
Special Risk Class	<u>20.10%</u> 18.66%
Special Risk Administrative Support Class	<u>10.88%</u> 11.54%
Elected Officers' Class— Legislators, Governor, Lt. Governor, Cabinet Officers, State Attorneys, Public Defenders	<u>10.04%</u> 10.70%
Elected Officers' Class— Justices, Judges	<u>15.62%</u> 14.90%
Elected Officers' Class— County Elected Officers	<u>11.79%</u> 12.39%
Senior Management Service Class	<u>8.73%</u> 8.56%
DROP	<u>9.37%</u> 8.49%

(5) In order to address unfunded actuarial liabilities of the system, the required employer retirement contribution rates for each membership class and subclass of the Florida Retirement System for both retirement plans are as follows:

Regular Class	<u>4.87%</u> 4.84%
Special Risk Class	<u>13.03%</u> 12.07%
Special Risk Administrative Support Class	<u>26.54%</u> 26.22%
Elected Officers' Class— Legislators, Governor, Lt. Governor, Cabinet Officers, State Attorneys, Public Defenders	<u>50.56%</u> 50.21%
Elected Officers' Class— Justices, Judges	<u>28.46%</u> 28.49%
Elected Officers' Class— County Elected Officers	<u>40.72%</u> 44.23%
Senior Management Service Class	<u>22.45%</u> 23.90%
DROP	<u>10.65%</u> 10.64%

Section 2. The Legislature finds that a proper and legitimate state purpose is served when employees, officers, and retirees of the state and its political subdivisions, and the dependents, survivors, and beneficiaries of such employees, officers, and retirees, are extended the basic protections afforded by governmental retirement systems. These persons must be provided benefits that are fair and adequate and that are managed, administered, and funded in an actuarially sound manner as required by s. 14, Article X of the State Constitution and part VII of chapter 112, Florida Statutes. Therefore, the Legislature determines and declares that this act fulfills an important state interest.

Section 3. This act shall take effect July 1, 2025.
