CHAPTER 2025-233

House Bill No. 4031

An act relating to the City of Oviedo, Seminole County; designating boundaries of an arts and entertainment district; providing an exception to general law; authorizing the Division of Alcoholic Beverages and Tobacco of the Department of Business and Professional Regulation to issue special licenses or modify existing licenses for bona fide licensees operating within such entertainment district for the sale of certain alcoholic beverages for consumption off the premises; providing that special licenses or modifications of existing licenses are in addition to certain other authorized temporary permits; requiring the bona fide licensees to comply with all other statutory requirements; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. There is created a special zone within the City of Oviedo to be known as the "Oviedo Arts and Entertainment District," more particularly described as follows:

thence S 42°17′13″ E. 187.44 feet to the point of curvature of a curve concave southwesterly having a radius of 135.00 feet; thence through a central angle of 31°15′20 run southeasterly along the arc of said curve and said west right of way line, 73.64 feet to the point of beginning and Lot 2 West of Eden as recorded in Plat Book 43, Pages 99 & 100 of the Public Records of Seminole County, Florida Together with the Northwest 1/4 of the Southwest 1/4 of the Southwest 1/4 of Section 15, Township 21 South, Range 31 East, Seminole County Florida.

Section 2. (1) Notwithstanding chapter 561, Florida Statutes, and any other provision of law, the Division of Alcoholic Beverages and Tobacco of the Department of Business and Professional Regulation shall issue, for bona fide licensees operating validly licensed premises within the Oviedo Arts and Entertainment District, at all times and throughout the entirety of the arts and entertainment district unless prohibited or limited in geographical area by the Oviedo City Council or its designee, a special license or modify an existing license to sell alcoholic beverages for consumption on the premises, in open containers, to be removed from the premises by patrons and consumed within the entertainment district. The type, design and color of the open container to be removed from the premises shall be identified by act of the City of Oviedo City Council.

- (2) The special licenses or modifications of existing licenses authorized by this act are in addition to any other temporary permits authorized pursuant to chapter 561, Florida Statutes.
- (3) The bona fide licensees shall comply with all other requirements of The Beverage Law during the special allowances authorized by this act.
 - Section 3. This act shall take effect upon becoming a law.
