CHAPTER 2025-249

Committee Substitute for House Bill No. 4071

An act relating to the City of Coral Springs and the City of Parkland, Broward County; reducing and contracting from the corporate limits of the City of Coral Springs and enlarging and extending the corporate limits of the City of Parkland approximately 8.7 acres of land contiguous to the corporate limits of the City of Parkland; providing boundaries; providing construction; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. The present corporate limits of the City of Coral Springs, Broward County, Florida, are hereby reduced and contracted so as to exclude, from the territory presently within the City of Coral Springs corporate limits, and the present corporate limits of the City of Parkland, Broward County, are hereby enlarged and extended so as to include, effective September 15, 2025, in addition to the territory presently within the City of Parkland corporate limits, an approximately 8.494 acre parcel of land, contiguous to the corporate limits of the City of Parkland, particularly described as follows:

A portion of Section 5, Township 48 South, Range 41 East, of Broward County, Florida; being more particularly described as follows:

Commencing at the Northwest corner of the Southwest quarter (S.W. ¹/₄) of said Section 5, said point also being the point of beginning; thence South 89°53'02" East, along the South line of the Northwest quarter (N.W. 1/4) of Section 5, a distance of 1,006.86 feet to the beginning of a curve concave Easterly, having a chord bearing of South 06°30'12" East; thence along said curve, having a radius of 290.00 feet, through a central angle of 34°35'18", an arc distance of 175.07 feet to a point of reverse curvature with a curve concave Westerly, having a chord bearing of South 02°47′44″ West; thence along said curve, having a radius of 147.00 feet, through a central angle of 53°09'52", an arc distance of 136.40 feet to the end of said curve; thence South 29°22'53" West, a distance of 43.06 feet to the beginning of a curve concave Northwesterly, having a chord bearing of South 56°27'14" West; thence along said curve, having a radius of 75.00 feet, through a central angle of 54°08'02", an arc distance of 70.86 feet to a point of reverse curvature with a curve concave Southeasterly, having a chord bearing of South 60°18'02" West; thence along said curve, having a radius of 200.00 feet, through a central angle of 46°26'25", an arc distance of 162.11 feet to a point of reverse curvature with a curve concave Northwesterly, having a chord bearing of South 55°05′02″ West; thence along said curve, having a radius of 100.00 feet, through a central angle of 36°00'25", an arc distance of 62.84 feet to the end of said curve; thence North 30°59'10" West, a distance of

136.65 feet; thence North 89°53'02" West, a distance of 464.50 feet; thence North 44°48'18" West, a distance of 308.15 feet to a point on the West line of the Southwest quarter (S.W. ¼) of said Section 5; thence North 00°49'39" West, along the West line of the Southwest quarter (S.W. ¼) of said Section 5, a distance of 156.83 feet to the point of beginning.

Said lands situate, lying and being in Broward County, Florida, containing 8.494 acres, more or less.

Section 2. The present corporate limits of the City of Coral Springs, Broward County, Florida, are hereby reduced and contracted so as to exclude, from the territory presently within the City of Coral Springs corporate limits, and the present corporate limits of the City of Parkland, Broward County, Florida, are hereby enlarged and extended so as to include, effective September 15, 2025, in addition to the territory presently within the City of Parkland corporate limits, an approximately 0.187 acre parcel of land, contiguous to the corporate limits of the City of Parkland, particularly described as follows:

A portion of Section 5, Township 48 South, Range 41 East, of Broward County, Florida; being more particularly described as follows:

Commencing at the Northwest corner of the Southwest quarter (S.W. ¹/₄) of said Section 5; thence South 00°49'39" East along the West line of the Southwest guarter (S.W. 1/4) of said Section 5, a distance of 156.83 feet; thence South 44°48'18" East, a distance of 308.15 feet; thence South 89°53'02" East, a distance of 464.50 feet; thence South 30°59'10" East, a distance of 136.65 feet to the point of beginning; thence South 30°59'10" East, a distance of 13.83 feet to the beginning of a curve concave Southerly, having a chord bearing of North 72°16′00″ East; thence along said curve, having a radius of 930.00 feet, through a central angle of 08°52'10", an arc distance of 143.96 feet to a point of reverse curvature with a curve concave Northwesterly, having a chord bearing of North 53°02'29" East; thence along said curve, having a radius of 90.00 feet, through a central angle of 47°19'14", an arc distance of 74.33 feet to the end of said curve; thence North 29°22'53" East, a distance of 37.58 feet to the beginning of a non-tangent curve concave Southeasterly, having a radial bearing of South 24°59'46" East and chord bearing of South 58°04'15" West; thence along said curve, having a radius of 177.72 feet, through a central angle of 13°51′58″, an arc distance of 43.01 feet to the end of said curve; thence South 70°36'09" West, a distance of 41.82 feet; thence South 58°27'42" West, a distance of 42.42 feet; thence South 46°10'27" West, a distance of 27.73 feet: thence North 49°49'35" West, a distance of 12.17 feet: thence North 46°10'18" East, a distance of 35.98 feet to the beginning of a curve concave Southerly, having a chord bearing of North 59°37'45" East; thence along said curve, having a radius of 150.00 feet, through a central angle of 26°54'49", an arc length of 70.46 feet to the end of said curve; thence North 73°05'10" East, a distance of

51.91 feet to the beginning of a curve concave Northerly, having a chord bearing of North $61^{\circ}49'32''$ East; thence along said curve, having a radius of 70.00 feet, through a central angle of $22^{\circ}31'26''$, an arc distance of 27.52 feet to the end of said curve; thence North $29^{\circ}22'41''$ East a distance of 32.65 feet, to the beginning of a curve concave Northerly, having a chord bearing of South $56^{\circ}27'14''$ West; thence along said curve, having a radius of 75.00 feet, through a central angle of $54^{\circ}08'02''$, an arc distance of 70.86 feet to a point of reverse curvature concave Southeasterly, having a chord bearing of South $60^{\circ}18'02''$ West; thence along said curve, having a radius of 200.00 feet, through a central angle of $46^{\circ}26'25''$, an arc distance of 162.11 feet to a point of reverse curvature with a curve concave Northwesterly, having a chord bearing of South $55^{\circ}05'02''$ West; thence along said curve, having a radius of 100.00 feet, through a central angle of $36^{\circ}00'25''$, an arc distance of 62.84 feet to the end of said curve, and the point of beginning.

Said lands situate, lying and being in Broward County, Florida, containing 0.187 acres, more or less.

Section 3. <u>This act may not be construed to affect or abrogate the rights</u> of parties to any contract, whether the same be between Broward County and a third party or between nongovernmental entities or otherwise, which contracts are in effect before the effective date of this act.

Section 4. This act shall take effect upon becoming a law.
