CHAPTER 98-26 Senate Bill No. 2504

An act making supplemental appropriations providing moneys from the annual periods beginning July 1, 1997 and ending June 30, 1998; to pay salaries, and other expenses, capital outlay - buildings and other improvements, and for other specified purposes of the various agencies of State government; supplementing appropriations as provided in Chapter 97-152, Laws of Florida; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

The moneys contained herein are appropriated from the named funds for the 1997-98 Fiscal Year to the State Agency indicated, as the amounts to be used to pay salaries and other operational expenditures of the named agencies, and are supplements to moneys appropriated in Chapter 97-152, Laws of Florida, the 1997-98 General Appropriations Act.

SECTION 2. The moneys contained herein are appropriated from the named funds to the Department of Education as the amounts to be used to pay the salaries, other operational expenditures and fixed capital outlay.

EDUCATION, DEPARTMENT OF, AND COMMISSIONER OF EDUCATION

PUBLIC SCHOOLS, DIVISION OF

From the funds in Specific Appropriation 105, \$3,150,133 shall be provided to the St. Lucie County school district and \$369,494 to the Gulf County school district to offset uncollected 1997-98 required local effort ad valorem revenues resulting from contested taxable value. As a condition of receipt of these funds, following final adjudication of litigation on the basis of which these funds are provided, the St. Lucie County and Gulf County school districts shall refund to the state within 30 days of receipt, any additional required local effort revenue received by the district as calculated by the Department of Education, utilizing taxable values approved by the court.
