CHAPTER 99-207

Senate Bill No. 750

An act relating to child care facilities; creating the "Jeremy Fiedelholtz Safe Day Care Act"; amending s. 402.319, F.S.; providing a penalty for making misrepresentations to certain persons regarding licensure or operation of a child care facility or family day care home; providing a penalty for negligence or intentional act and the parent or guardian relied on a misrepresentation; amending s. 921.0022, F.S.; providing for ranking of violations on the offense severity ranking chart; amending s. 110.151, F.S.; providing duties for state agencies sponsoring child care programs for children and dependents of state officers and employees; providing effective dates.

Be It Enacted by the Legislature of the State of Florida:

- Section 1. This act may be cited as the "Jeremy Fiedelholtz Safe Day Care Act."
 - Section 2. Section 402.319, Florida Statutes, is amended to read:
 - 402.319 Penalties.—
- (1) It is a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083, for any person willfully, knowingly, or intentionally to:
- (a)(1) Fail, by false statement, misrepresentation, impersonation, or other fraudulent means, to disclose in any application for voluntary or paid employment or licensure regulated under ss. 402.301-402.318 all information required under those sections or a material fact used in making a determination as to such person's qualifications to be child care personnel, as defined in s. 402.302, an owner, operator, employee, or volunteer in a child care facility, family day care home, or other child care program.
- (b)(2) Operate or attempt to operate a child care facility without having procured a license as required by this act.
- (c)(5) Operate or attempt to operate a family day care home without a license or without registering with the department, whichever is applicable.
- (d)(3) Operate or attempt to operate a child care facility or family day care home under a license that is suspended, revoked, or terminated.
- (e)(4) <u>Misrepresent</u> Represent, by act or omission, a child care facility or family day care home to be duly licensed pursuant to this act without being so licensed.
- (f) Make any other misrepresentation, by act or omission, regarding the licensure or operation of a child care facility or family day care home to a

parent or guardian who has a child placed in the facility or is inquiring as to placing a child in the facility, or to a representative of the licensing authority, or to a representative of a law enforcement agency, including, but not limited to, any misrepresentation as to:

- 1. The number of children at the child care facility or the family day care home;
- 2. The part of the child care facility or family day care home designated for child care;
 - 3. The qualifications or credentials of child care personnel;
- 4. Whether a family day care home or child care facility complies with the screening requirements of s. 402.305; or
- $\underline{5}$. Whether child care personnel have the training as required by \underline{s} . 402.305.
- (2) If any child care personnel makes any misrepresentation in violation of this section to a parent or guardian who has placed a child in the child care facility or family day care home, and the parent or guardian relied upon the misrepresentation, and the child suffers great bodily harm, permanent disfigurement, permanent disability, or death as a result of an intentional act or negligence by the child care personnel, then the child care personnel commits a felony of the second degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.
- Section 3. Paragraph (g) of subsection (3) of section 921.0022, Florida Statutes, 1998 Supplement, is amended to read:

Section 4. Subsection (2) of section 110.151, Florida Statutes, is amended to read:

110.151 State officers' and employees' child care services.—

(2) Child care programs may be located in state-owned office buildings, educational facilities and institutions, custodial facilities and institutions, and, with the consent of the President of the Senate and the Speaker of the House of Representatives, in buildings or spaces used for legislative activities. In addition, centers may be located in privately owned buildings conveniently located to the place of employment of those officers and employees to be served by the centers. If a child care program is located in a state-owned office building, educational facility or institution, or custodial facility or institution, or in a privately owned building leased by the state, a portion of the service provider's rental fees for child care space may be waived by the sponsoring agency in accordance with the rules of the Department of Management Services. Additionally, the sponsoring state agency may be responsible for the maintenance, utilities, and other operating costs associated with the physical facility of the child care center.

Section 5. This act shall take effect October 1, 1999, except that this section and section 4 of this act shall take effect July 1, 1999.
