CHAPTER 2002-76

Committee Substitute for Senate Bill No. 434

An act providing for the submission of current information for the preparation of jury lists; amending s. 40.011, F.S.; requiring the Department of Highway Safety and Motor Vehicles to periodically deliver jury lists to the clerks of circuit courts; amending s. 40.022, F.S.; requiring the Department of Law Enforcement to establish procedures for submitting certain information; amending s. 322.051, F.S.; requiring applications for identification cards issued by the Department of Highway Safety and Motor Vehicles to specify the county of residence; amending s. 322.08, F.S.; requiring applications for driver's licenses to specify the county of residence; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsection (1) of section 40.011, Florida Statutes, is amended to read:

40.011 Jury lists.—

- The Department of Highway Safety and Motor Vehicles shall deliver quarterly to the clerk of the circuit court in each county a list of names of persons who reside in that county, who are citizens of the United States, who are legal residents of Florida, who are 18 years of age or older, and for whom the department has a driver's license or identification card record. On or before January 1, 1993, and each year thereafter by January 1, the Department of Highway Safety and Motor Vehicles shall deliver to the clerk of the circuit court in each county a list of names, along with mailing addresses and dates of birth, of each person 18 years of age or older whose name appears in the department database and whose address is in that county. By January 1, 1992, the department shall begin the process of identifying persons whose names appear in the department database who are not citizens of the United States and legal residents of this state for the purpose of jury selection. By January 1, 1998, the department database list delivered to the clerk of the circuit court in each county may include only the names of persons who are citizens of the United States and legal residents of Florida and whose address is in that county and who are 18 years of age or older. The clerk of the circuit court shall add to the list the name of any person who is 18 years of age or older and who is a citizen of the United States and a legal resident of Florida and who indicates a desire to serve as a juror, but whose name does not appear on the department database list, by requiring such person to execute an affidavit at the office of the clerk.
- Section 2. Subsection (4) is added to section 40.422, Florida Statutes, to read:
 - 40.022 Clerk to purge jury selection lists; restoration.—
- (4) The Department of Law Enforcement shall establish procedures to enable the clerk of the court in each county to submit monthly the names

and other identifying information about the persons selected for the jury list. The Department of Law Enforcement will search its databases and return an automated file of matching records that would assist the clerk in evaluating whether a member of the jury pool should be disqualified under the provisions of s. 40.013(1).

Section 3. Subsection (1) of section 322.051, Florida Statutes, is amended to read:

322.051 Identification cards.—

- (1) Any person who is 12 years of age or older, or any person who has a disability, regardless of age, who applies for a disabled parking permit under s. 320.0848, may be issued an identification card by the department upon completion of an application and payment of an application fee.
- (a) Each such application shall include the following information regarding the applicant:
- 1. Full name (first, middle or maiden, and last), gender, social security card number, <u>county of</u> residence and mailing address, and a brief description.
 - 2. Proof of birth date satisfactory to the department.
- 3. Proof of identity satisfactory to the department. Such proof must include one of the following unless a driver's license record or identification card record has already been established: a certified copy of a United States birth certificate, a valid United States passport, an alien registration receipt card (green card), an employment authorization card issued by the United States Department of Justice, or proof of nonimmigrant classification provided by the United States Department of Justice, for an original identification card.
- (b) An application for an identification card must be signed and verified by the applicant in a format designated by the department before a person authorized to administer oaths. The fee for an identification card is \$3, including payment for the color photograph or digital image of the applicant.
- Section 4. Subsection (2) of section 322.08, Florida Statutes, is amended to read:
 - 322.08 Application for license.—
- (2) Each such application shall include the following information regarding the applicant:
- (a) Full name (first, middle or maiden, and last), gender, social security card number, <u>county of</u> residence and mailing address, and a brief description.
 - (b) Proof of birth date satisfactory to the department.
- (c) Proof of identity satisfactory to the department. Such proof must include one of the following unless a driver's license record or identification

card record has already been established: a certified copy of a United States birth certificate, a valid United States passport, an alien registration receipt card (green card), an employment authorization card issued by the United States Department of Justice, or proof of nonimmigrant classification provided by the United States Department of Justice, for an original license.

(d) Whether the applicant has previously been licensed to drive, and, if so, when and by what state, and whether any such license or driving privilege has ever been disqualified, revoked, or suspended, or whether an application has ever been refused, and, if so, the date of and reason for such disqualification, suspension, revocation, or refusal.

Section 5. This act shall take effect October 1, 2002.
