CHAPTER 2011-251

House Bill No. 861

An act relating to the North Springs Improvement District, Broward County; amending chapter 2005-341, Laws of Florida, as amended; extending and enlarging the boundaries of the district; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 2 of section 3 of chapter 2005-341, Laws of Florida, as amended by chapter 2010-269, Laws of Florida, is amended to read:

Section 2. Boundaries.—The boundaries of the district shall be:

A tract of land being Sections 5, 6, 7, 8, 9 and 10, a portion of Sections 3 and 4, all in Township 48 South, Range 41 East, Broward County, Florida, and Sections 31, 32 and 33, a portion of Sections 20, <u>26, 27, 28, 29 and 30</u>, all in Township 47 South, Range 41 East, Broward County, Florida, described as follows:

BEGINNING at the southwest corner of said Section 7;

thence North 89°50′50″ East, along the north line of said Southeast Quarter (SE1/4), a distance of <u>562.93</u> 2098.87 feet to the northeast corner of said Southeast Quarter (SE1/4) and the southwest corner of the Northwest Quarter (NW1/4) of said Section 29;

thence North 89°46'05" West, along the south line of the Southwest Quarter (SW1/4) of said Section 7, a distance of 2399.06 feet to the POINT OF BEGINNING.

Section 2. This act shall take effect upon becoming a law.
