CHAPTER 2015-192

House Bill No. 969

An act relating to the North Springs Improvement District, Broward County; amending chapter 2005-341, Laws of Florida, as amended; extending and enlarging the boundaries of the district; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 2 of section 3 of chapter 2005-341, Laws of Florida, as amended by chapter 2011-251, Laws of Florida, is amended to read:

Section 2. Boundaries.—The boundaries of the district shall be:

A tract of land being Sections 5, 6, 7, 8, 9 and 10, a portion of Sections 3 and 4, all in Township 48 South, Range 41 East, Broward County, Florida, and Sections 31, 32 and 33, a portion of Sections 19, 20, 26, 27, 28, 29 and 30, all in Township 47 South, Range 41 East, Broward County, Florida, described as follows:

BEGINNING at the southwest corner of said Section 7;

thence North 00°03′12″ West (Bearings are relative to State Plane Coordinates as shown on STONER/KEITH RESURVEY OF A PORTION OF TOWNSHIP 47 SOUTH, RANGE 41 EAST, ALL OF TOWNSHIP 48 SOUTH, RANGE 41 EAST, & ALL OF TOWNSHIP 49 SOUTH, RANGE 41 EAST, according to the plat thereof, recorded in Miscellaneous Plat Book 3 at Page 44 of the Public Records of said Broward County), along the west line of the Southwest Quarter (SW ¼) of said Section 7, a distance of 2647.42 feet to the northwest corner of said Southwest Quarter (SW ¼);

thence North 00°04′32″ West, along the west line of the Northwest Quarter (NW ¼) of said Section 30, a distance of 2642.88 feet to the northwest corner of said Northwest Quarter (NW ¼);

Also being the Southwest corner of the Southwest Quarter (SW ¼) of said Section 19, Township 41 South, Range 41 East;

thence North 00°07′09″ West 1312.53 feet along the west line of said Southwest Quarter (SW 1/4);

thence South 68°26′01″ East 263.00 feet to a line parallel with and 250.00 feet East of the West line of said Southwest Quarter (SW ¼);

thence North 00°07′09″ West 870.00 feet along said parallel line to the southerly right-of-way line of State Road 827;

thence South 71°31′57″ East 2037.21 feet along said southerly right-of-way line;

thence South 00°42′16″ East 1424.47 feet along the east line of said Southwest Quarter (SW 1/4) to the southeast corner of said Southwest Quarter;

thence North 89°34′40″ East, along the north line of the Northeast Quarter (NE ¼) of said Section 30, a distance of 118.81 feet to a line parallel with and 118.81 118.11 feet east of the west line of the Southeast Quarter (SE 1/4) of said Section 19 said Northeast Quarter (NE 1/4);

thence North 00°42′16″ West South 00°40′57″ East, along said parallel line a distance of 1406.20 2653.89 feet to the southerly right-of-way south line of said State Road 827 Northeast Quarter (NE¾) and the north line of the Southeast Quarter (SE¾) of said Section 30;

thence South 72°01′08″ East 262.96 feet along said southerly right-ofway line;

thence North 89°32′07″ East 78.99 feet;

thence South 72°00′49″ East 246.97 feet;

thence South 00°41′51″ East 87.48 feet thence North 89°50′50″ East, along the north line of said Southeast Quarter (SE¼), a distance of 562.93 feet:

thence North 00°50′04″ West 3816.85 feet;

thence South 76°31'46" East <u>756.30</u> 765.36 feet;

thence North 00°41′ 26″ West 29.46 feet;

thence South 71°52′41″ East along said southerly right-of-way line 2211.87 2210.69 feet:

thence South 01°16′02″ East 305.48 feet to the south line of the Southwest Quarter (SW ¼) of said Section 20 and the north line of the Northwest Quarter (NW ¼) of said Section 29;

thence South 01°16′02″ East, along a northerly prolongation of the east line of Tracts 15 and 16 in said Section 29, according to the Plat of FLORIDA FRUIT LANDS COMPANY'S SUBDIVISION NO. 2, as recorded in Plat Book 1 at Page 102 of the Public Records of Palm Beach County, Florida and along said east line a distance of 1331.52 feet to the northwest corner of Tract 11 of said Plat;

thence North 89°41′40″ East, along the north line of said Tract 11 and an easterly prolongation thereof, a distance of 1320.53 feet to the west line of the Northeast Quarter (NE ¼) of said Section 29;

thence North 01°16′25″ West, along said west line, a distance of 1197.77 feet to the southerly right-of-way line of State Road No. 827 as it now exists;

thence along said southerly right-of-way line South 72°00′16″ East 5594.00 feet to the East line of the Southeast Quarter (SE 1/4) of said Section 28:

thence South 72°00′16 East, along said southerly right-of-way line, a distance of 5594.00 feet:

thence South 71°59′55″ East along said southerly right-of-way line, 5673.26 feet to a line parallel with and 75.00 feet east of the East line of the Southeast Quarter (SE ¼) of said Section 27;

thence South 01°20′51″ East along said parallel line 673.65 feet to the south line of said Section 26;

thence South 89°38′57″ West along said south line, 75.01 feet to the Southwest corner of said Section 26;

thence North 01°20′51″ West along the west line of said Section 26, 285.33 feet;

thence parallel with and 390.00 feet southerly of the aforesaid southerly right-of-way line, North 71°59′55″ West 5594.63 feet to the east line of said Section 28

thence South 01°14′06″ East, along said east line, a distance of 2047.04 feet to the southeast corner of said Section 28 and the northeast corner of Northeast Quarter (NE ¼) of said Section 33;

thence South 01°21′19″ East, along the east line of said Northeast Quarter (NE ¼), a distance of 2638.16 feet to the southeast corner of said Northeast Quarter (NE ¼);

thence South 89°44′30″ West, along the north line of the Northeast Quarter (NE ¼) of said Section 4, a distance of 60.00 feet to the most westerly corner of that parcel of land described in Official Record Book 33011 55 at Page 280 500 of said Public Records of Broward County;

thence South 45°33′09″ East, along the southwesterly line of said parcel and along the Southwesterly line of that parcel of land described in Official Records Book 37079 at page 869 of said Public Records of Broward County, a distance of 85.27 85.29 feet to the most southerly corner of said parcel on the east line of said Northeast Quarter (NE ¼);

thence South 00°50′47″ East, along said east line, a distance of 3303.78 feet to the southeast corner of said Northeast Quarter (NE ¼) and the northwest corner of the Southwest Quarter (SW ¼) of said Section 3;

thence South 89°52′36″ East, along the north line of the said Southwest Quarter (SW ¼) of said Section 3, a distance of 2640.57 feet to the northeast corner of said Southwest Quarter. (SW ¼);

thence South 89°52′36″ East, along the north line of the Southeast Quarter (SE ¼) of said Section 3, a distance of 2639.23 feet to the northeast corner of said Southeast Quarter (SE ¼);

thence South 00°53′22″ East, along the east line of said Southeast Quarter (SE ¼), a distance of 3401.43 feet to the southeast corner of said Section 3 and the northeast corner of said Section 10;

thence South $00^{\circ}59'18''$ East, along the east line of the Northeast Quarter (NE $\frac{1}{4}$) of said Section 10, a distance of 2637.04 feet to the southeast corner of said Northeast Quarter (NE $\frac{1}{4}$);

thence South 00°59′17″ East, along the east line of the Southeast Quarter (SE ¼) of said Section 10, a distance of 2637.03 feet to the southeast corner of said Section 10;

thence North $89^{\circ}25'05''$ West, along the south line of said Southeast Quarter (SE $\frac{1}{4}$), a distance of 2637.48 feet to the southwest corner of said Southeast Quarter (SE $\frac{1}{4}$);

thence continue North 89°25′05″ West, along the south line of the Southwest Quarter (SW ¼) of said Section 10, a distance of 2637.47 feet to the southwest corner of said Section 10 and the southeast corner of said Section 9;

thence North 89°26′06″ West, along the south line of the Southeast Quarter (SE ¼) of said Section 9, a distance of 2641.24 feet to the southwest corner of said Southeast Quarter (SE ¼);

thence continue North 89°26′06″ West, along the south line of the Southwest Quarter (SW ¼) of said Section 9, a distance of 2641.24 feet to the southwest corner of said Section 9 and the southeast corner of said Section 8;

thence North 89°25′53″ West, along the south line of the Southeast Quarter (SE ¼) of said Section 8, a distance of 2639.96 feet to the southwest corner of said Southeast Quarter (SE ¼);

thence North 89°25′52″ West, along the south line of the Southwest Quarter (SW ¼) of said Section 8, a distance of 2639.96 feet to the southwest corner of said Section 8 and the southeast corner of said Section 7;

thence North 89°46′06″ West, along the south line of the Southeast Quarter (SE ¼) of said Section 7, a distance of 2399.06 feet to the southwest corner of said Southeast Quarter (SE ¼);

thence North $89^{\circ}46'05''$ West, along the south line of the Southwest Quarter (SW $\frac{1}{4}$) of said Section 7, a distance of 2399.06 feet to the POINT OF BEGINNING.

Less therefrom the following described parcel:

A portion of the Southwest Quarter (SW 1/4) of said Section 28 described as follows:

COMMENCING BEGINNING at the southwest corner of said Southwest Quarter (SW 1/4);

thence North 89°36′59″ East, along the south line of said Southwest Quarter (SW 1/4), a distance of 30.00 feet to the Point of Beginning;

Thence North 01°15′11″ West, along a line parallel with and 30.00 feet east of the west line of said Southwest Quarter (SW ¼), a distance of 769.83 feet to a line parallel with and 769.74 feet north of the south line of said Southwest Quarter;

thence North 89°36′59″ East, along said parallel line, a distance of 1387.00 feet to a line parallel with and 1416.84 feet <u>east</u> west of the west line of said Southwest Quarter;

thence South 01°15′11″ East, along said parallel line, a distance of 769.83 feet to the south line of said Southwest Quarter (SW 1/4);

thence South 89°36′59″ West, along said south line, a distance of 1387.00 feet to the POINT OF BEGINNING.

Said land being in Broward County, Florida.

Containing <u>8759.209</u> 8683.696 acres, more or less.

Section 2. This act shall take effect upon becoming a law.
